
### CERTIFICATE OF AMENDMENT OF

Pursuant to Section 30-3-93 of the Idaho Code the undersigned corporation adopts the following Articles of Amendment to it's Articles of Incorporation:

ONE: The name of the corporation is **TWIN FALLS BOARD OF REALTORS, INC.**

TWO: The following amendments to the Articles of Incorporation were unanimously adopted by the members of the corporation on June 9, 1992, in the manner prescribed by the laws of the State of Idaho, and the Articles of Incorporation of the corporation;

1. The name of the corporation shall be changed to **GREATER TWIN FALLS ASSOCIATION OF REALTORS, INC.**

2. The registered agent of the corporation shall be changed to Janey McAnulty whose address is the same as the address for the corporate office, that address being 1525 Addison Avenue, Twin Falls, Idaho, 83301.

3. "Fourth" on page 4 shall be amended to provide for an authorization of unlimited memberships.

THREE: The hereinabove stated amendments were adopted by unanimous vote of the members of the corporation on the 9th day of June, 1992.
