

ARTICLES OF INCORPORATION OF THE

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we hereby

CERTIFY:--

-I-

That the name of said corporation is the ANDERSON, BLOMQUIST COMPANY, LIMITED.

-II-

That the purposes for which this corporation is formed are to carry on a general merchandise business in Boise City, Ada County, State of Idaho, and in such other places in said State as may hereafter be selected.

-III-

That the place where the principal business of this corporation is to be transacted, shall be Boise City, Ada County, State of Idaho.

-IV-

That the term for which this corporation is to exist is fifty years from the date of its incorporation.

-V-

That the number of its directors shall be five, and that the names and residences of those who are appointed for the first year are:--
