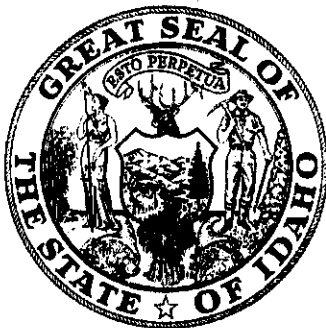
CERTIFICATE OF DISSOLUTION OF
