The name of this corporation is DOUG'S TOWING AND AUTOBODY, INC.

ARTICLE II.

The purpose or purposes for which the corporation is organized are, without limiting the powers granted by the Laws of the State of Idaho, as follows:

- a. To engage in the business of towing vehicles.
- b. To engage in the business of automotive repair and maintenance, and autobody work.
- c. To engage in activities that are necessary, suitable, or convenient for the accomplishment of the above stated purposes, or which are incidental thereto or connected therewith.

ARTICLE III.

This corporation shall have a perpetual existence.

ARTICLE IV.

The total number of shares which the corporation is authorized to issue is one thousand (1000). The aggregate par value of such shares is -0- and the par value of each share is -0-.


