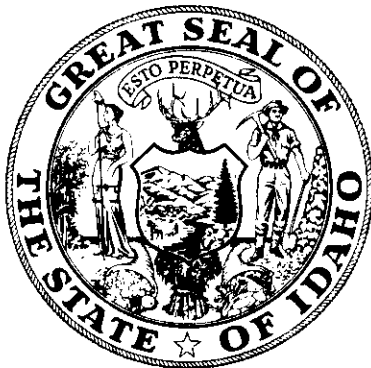

1. Amendment to Article IX

Upon the winding up and dissolution of this corporation; after paying or adequately providing for the debts and obligations of the organization; the remaining assets shall be distributed to first the American Missionary Fellowship, a non-profit Pennsylvania Corporation which has established its tax exempt status under Section 501 (c) (3) of the Internal Revenue Code, or if the American Missionary Fellowship is nonexistant, Second, to Northwest Independent Church Extension, a Washington non-profit corporation which has established its tax exempt status under Section 501 (c) (3) of the Internal Revenue Code.

2. The following amendment is an addition to the original Articles of Incorporation.

Article X

Notwithstanding any other provision of these articles the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code.

3. As there are no members, the above amendments were adopted by a majority of the board of directors at the Annual Meeting, October 17, 1981.
