KNOWN ALL MEN BY THESE PRESENTS that we, the undersigned, being natural persons of full age and all citizens of the United States, in order to form a corporation for the purposes hereinafter stated pursuant to the Business Corporation Act of the State of Idaho, do hereby certify as follows:

- 1. Name. The name of the corporation is Precision Electric Co.
 - 2. Purposes. The purposes of the corporation shall be:
 - (a) To engage in the business of electrical contracting, installation of electrical systems in homes, businesses, and other types of improvements on real property, the construction of electrical lines and transmissions lines, and any and all other types of business which may be done under the Laws of the State of Idaho.
 - (b) To act as agent or attorney in fact and/or maintain an agency or agencies for any and all surety, fidelity or bonding companies authorized to do business in the State of Idaho or elsewhere.
 - (c) To engage in any and all types of business enterprises which the corporation may from time to time find necessary, desirable or convenient to do in connection with the general electrical business.
 - (d) To purchase, lease, own, sell, mortgage, sublease, or otherwise acquire or dispose of land, buildings, easements or property, both real and personal, including all types and kinds of equipment which are requisite for or are conveniently capable of being conveniently used in connection with any of the objects of this corporation, and to enter into, make, perform and carry out contracts of every sort and kind with any person, and to acquire and take over the good will, property rights, liabilities, of any person, form, or corporation, either wholly or in part, and to pay for the same

in cash, stocks or bonds of the corporation or otherwise.

- (e) To purchase or acquire property, business, rights or franchises or for any other object in or about its business affairs, to incur debt and to borrow and secure the payment of money in any lawful manner, including the issue and sale or other disposition of bonds, debentures, notes or other evidence of indebtedness, and to acquire by purchase, gift, or otherwise, shares of its own corporate stock and cancel the same or any part thereof or hold all or any of such stock for resale as treasury stock, or for the purpose of making stock shareholders, and to dividends to its restrict transferability of its outstanding shares to the extent reasonably necessary to protect the rights of the corporation and its shareholders in any stock purchase, contracts, or options that may be made between themselves or any of them.
- (f) To act as surety or creditor in any and all types of engagement, including the power to execute, endorse and deliver contracts and to guarantee the prompt and faithful performance for payment of debts, notes, agreements, contracts, and undertakings of any other person, firm, partnership or corporation, and to act as accommodation, comaker or guarantor on obligations either as primary or secondary obligor.
- (g) Without in any manner limiting any of the objects, purposes or powers of corporation, the business or purpose of said corporation shall be from time to time to do any one or more or all of the acts or things herein set forth.
- (h) The several subdivisions contained in this paragraph of purposes shall be construed as both purposes and powers and the enumeration thereof shall not be held to limit or restrict in any manner the general powers conferred on business corporations by the laws of the State of Idaho, all of which powers are hereby expressly claimed.
- 3. <u>Duration</u>. The duration of the corporation shall be perpetual.
- 4. Registered Office. The registered office of said corporation in the State of Idaho shall be located in Fairfield, Idaho, in the County of Camas, and that the post office address of the registered office of said corporation in the State of Idaho is P. O. Box 467, Fairfield, Idaho 83327. The registered agent of the

corporation is Willis H. Castle, Jr., whose address is P. O. Box 467, Fairfield, Idaho 83327.

- 5. <u>Capital Stock</u>. The total authorized number of par value shares of the corporation is 700 shares of common stock with equal rights. Said stock shall have no par value.
- 6. <u>Incorporators</u>. The amount of capital stock of said corporation which has been actually subscribed is one (1) share, and the following is the name and post office address of the incorporator and initial director and the number of shares subscribed.

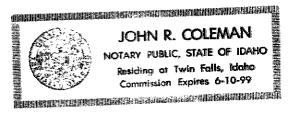
