ARTICLES OF INCORPORATION SECRETARY OF STATE

OF

HOME-BASED BUSINESSES OF IDAHO, INC.

In compliance with the requirements of the law of Idaho relating to nonprofit corporations and acts amendatory and supplemental thereto, including particularly Title 30, Chapter 3, Idaho Code, the undersigned natural person, being of full age and a resident of the United States, in order to form a nonprofit corporation for the purposes hereinafter stated, does hereby as incorporator, adopt the following Articles of Incorporation and certify:

ARTICLE I

NAME

The name of the Corporation is Home-Based Businesses of Idaho, Inc. hereinafter called the "Corporation."

ARTICLE II

NONPROFIT CORPORATION

This Corporation is a nonprofit corporation.

ARTICLE III

DURATION

The duration of this Corporation shall be perpetual.

ARTICLE IV

PURPOSE AND POWERS OF THE CORPORATION

This corporation shall be a nonprofit membership corporation. The purpose of the Corporation shall be to promote Idaho Home-Based Businesses, to keep members informed of opportunities or legislation

that may affect their business, to increase public awareness of the many professional experts available locally and to encourage the purchase of goods and services of Idaho Home-Based businesses.

A. Have and to exercise any and all powers, rights and privileges which a corporation organized under the laws for general nonprofit corporations in the State of Idaho by law may now or hereafter have or exercise.

ARTICLE V

MEMBERSHIP

There shall be unlimited members in the Corporation. Members are considered to be in good standing upon payment of the annual dues investment in an appropriate classification in current schedule as approved by the Board of Directors.

ARTICLE VI

VOTING RIGHTS

Voting rights are exercised by the Board of Directors duly elected according to Article III, Section II of the by-laws.

ARTICLE VII

CORPORATION ADDRESS

The street address of the initial registered office of the Corporation shall be 5245 Willamette, Boise, Idaho 83705. The name of the initial registered agent shall be Nancy Chinn at the aforementioned street address.

ARTICLE VIII

BOARD OF DIRECTORS

The initial Board of Directors shall be comprised of 5 members, who shall be members of the Corporation.

AMENDMENT OF ARTICLES

Amendments to these Articles of Incorporation shall require the assent of those members casting two-thirds (2/3) of the votes ARTICLES OF INCORPORATION, P.2 of the Corporation at any regular members' meeting or a special meeting called specifically for that purpose.
