THIS IS TO CERTIFY that the Articles of Incorporation of The First Presbyterian Church of Moscow, Idaho were amended on January 27, 1974 in the manner hereinafter set forth.


1. The First Presbyterian Church of Moscow, Idaho is a religious association incorporated under Idaho Code Title 30, Chapter 11.

2. On January 27, 1974 at the regular meeting of the members of the corporation, at 405 South Van Buren Avenue, City of Moscow, Latah County, State of Idaho, a majority of the quorum attending said meeting voted to adopt the ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION attached to this certificate and made a part thereof by reference.

3. Notice of intention to amend the Articles of Incorporation in this manner was published in the Dally Idahonian, a newspaper published at Moscow, Idaho, on January 5, 12, 19 and 26, 1974, designating the regular meeting at which it was intended to vote on the proposition of amending the Articles of Incorporation and setting forth in full the text of the amendments proposed.

4. Duplicates of this certificate shall be filed in the office of the Latah County Recorder and the Idaho Secretary of State.

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

OF

THE FIRST PRESBYTERIAN CHURCH OF MOSCOW, IDAHO

KNOW ALL MEN BY THESE PRESENTS:

I.

That Articles of Incorporation of the First Presbyterian Church of Moscow, Idaho, were filed with the Secretary of State, then territory of Idaho, on November 5, 1883; that said Articles of Incorporation were replaced by Amended Articles of Incorporation of The First Presbyterian Church of Moscow, Idaho, adopted on April 28, 1903, and duly filed with the Secretary of State; that said Amended Articles of Incorporation were themselves amended by Articles of Amendment filed with the Secretary of State July 16, 1958; and that the 1903 Amended Articles of Incorporation, as amended by the 1958 Articles of Amendment, are hereby further amended by these Articles of Amendment dated January 27, 1974.

II.

That Article 2nd of the said Amended Articles of Incorporation is hereby amended by deleting the words "the Presbyterian Church of the U.S. of America," and substituting in their place the words, "The United Presbyterian Church in the United States of America, or its successors."

III.

That Article 6th of said Amended Articles of Incorporation is hereby amended by deleting the text of said Article 6th in its entirety and substituting in its place the following:

"The number of officers and directors, their terms, duties and manner of election, and other matters of internal organization shall be set forth in the Bylaws."

IV.


That Article 7th of the said Amended Articles of Incorporation is

hereby amended by deleting the words, "the Presbyterian Church of The U.S. of America," and substituting in their place the words, "The United Presbyterian Church in the United States of America, or its successors."

V.

That Article 8th of said Amended Articles of Incorporation is hereby deleted in its entirety.
