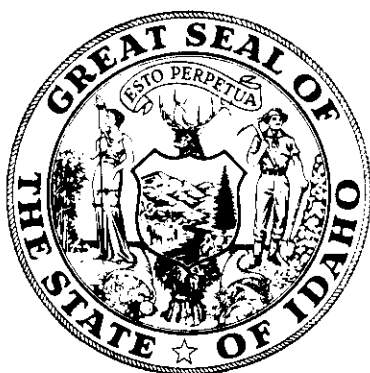


1. The name of the corporation is Atlantic Gulf Company
