WHEREAS, URLS, LLC is an Idaho limited liability company ("URLS Idaho"). Its sole member is the Unger Disclaimer Trust under the Unger Family Trust, u/a/d June 28, 1997.

WHEREAS, the sole member of URLS Idaho has determined that it is in the best interests of URLS, LLC and its sole member to domesticate URLS Idaho to the state of Wyoming.

NOW, THEREFORE, this Statement of Domestication is hereby adopted as follows:

1. The name of the domesticating entity is URLS, LLC, and it is an Idaho limited liability company ("URLS Idaho").
2. The name of the domesticated entity is URLS, LLC ("URLS Wyoming") and it is a Wyoming limited liability company.
3. The sole member of URLS Idaho has executed a written consent to the domestication of URLS Idaho to URLS Wyoming. The Plan of Domestication was approved in accordance with Section 30-6-1001 et seq of the Idaho Limited Liability Company Act and Section 30-18-501 et seq of the Idaho Entity Transactions Act.
4. The proposed Articles of Domestication for URLS Wyoming are attached to this Statement as Exhibit 1.
5. The mailing address for service of process is: Post Office Box 417, Ketchum, Idaho, 83340.
6. The Effective Date of the domestication is the date by which all of the documents required under the laws of the State of Idaho and Wyoming have been filed and accepted by both the Secretaries of State of Idaho and Wyoming.


