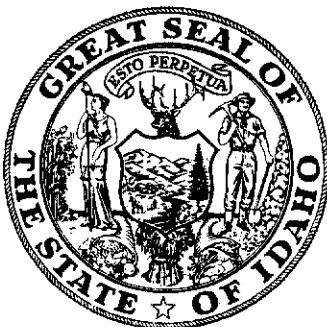

ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the Corporation is BIG BOYZ TOYZ, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose for which the Corporation is organized is to engage in the business of sale and repair of recreational vehicles and any other business which a corporation may engage in under the laws of the State of Idaho.

FOURTH: The aggregate number of shares which the Corporation shall have authority to issue is 1,000 common stock with no par value.

FIFTH: The transfer of the shares of the Corporation are restricted and such restriction is specified in the By-laws of the Corporation.

SIXTH: The address of the initial registered office of the Corporation is 3703 Overland, Boise, Idaho 83705 and the name of its initial registered agent at such address is Clayton Pederson.

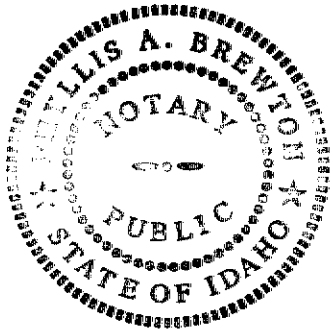

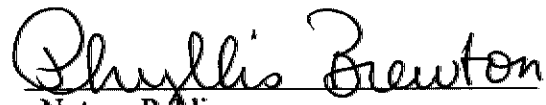
