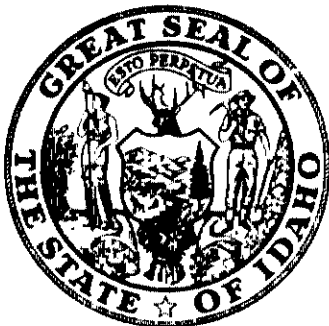

TO THE ARTICLES OF INCORPORATION  
OF  
ALPINE VILLA HOME OWNERS ASSOCIATION

Pursuant to the Idaho Non-profit Corporation Act, the following Articles of Amendment are hereby adopted.

1. NAME OF THE CORPORATION. The name of the corporation prior to the amendment called for herein was Alpine Villa Home Owners Association. The new name of the corporation is, and shall hereafter be, Trail View Condominium Association, Inc.

2. ADOPTION OF AMENDMENT. Article 1 of the Articles of Incorporation is amended to read as follows: "Article 1. The name of the corporation is Trail View Condominium Association, Inc., hereinafter called the "Association."

3. DATE OF ADOPTION OF AMENDMENT. The date of the adoption of the Articles of Amendment by the members of the corporation was September 4 , 1994.

4. MEMBERS APPROVAL. The Amendment was adopted at the annual membership meeting of the corporation on September 4, 1994. 80.04415% of the members of the corporation were present or represented by proxy at the annual meeting. All of the members present and by proxy at the meeting voted for the amendment to change the name of the corporation to Trail View Condominiums Association, Inc.. No members voted in opposition to the Amendment. There is only one class of members of the corporation.

IN WITNESS WHEREOF, the undersigned, President and Secretary of the corporation have executed these Articles of Amendment this 6 day of February, 1995.

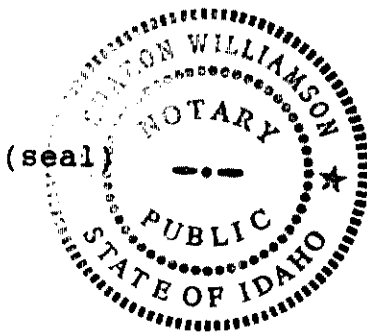
