ARTICLES OF INCORPORATION

OF

MOUNTAIN ALARM CORPORATION

THE UNDERSIGNED, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is MOUNTAIN ALARM CORPORATION.

SECOND: The period of its duration is perpetual.

THIRD: The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 30,000 at a par value of one dollar per share.

FIFTH: No preemptive rights are to be denied the shareholders.

SIXTH: Provisions for the internal affairs are to be in compliance with the laws of the State of Idaho.

SEVENTH: The address of the initial registered office of the corporation is 2309 Mountain View Drive, Boise, Idaho 83706, and the name of its initial registered agent at such address is David B. Vaughn.
