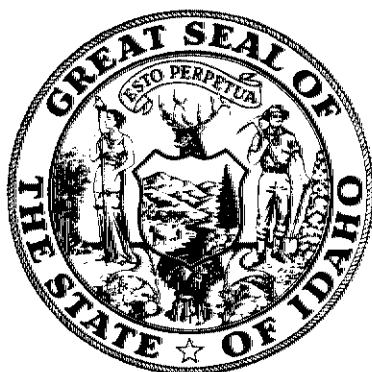

6 The undersigned, acting as incorporators of a corporation
7 under the Idaho Business Corporation Act, adopt the following
8 Articles of Incorporation for such corporation:

10 The name of the corporation is REID ENTERPRISES, INC.

12 The period of its duration is perpetual.
