ARTICLES OF INCORPORATION

OF

REID ENTERPRISES, INC.

KNOW ALL BY THESE PRESENTS:

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

I.

The name of the corporation is REID ENTERPRISES, INC.

II.

The period of its duration is perpetual.

III.

The purpose or purposes for which the corporation is organized are: Consultation and teaching shortcourses in structural
geology, as well as including the transaction of any or all lawful
business for which corporations may be incorporated under the
Idaho Business Corporation Act.
