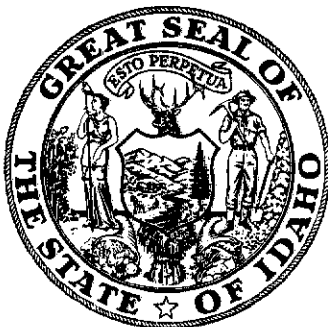

ARTICLES OF INCORPORATION

OF

TIGHTLINE LOGGING, INC.

The undersigned incorporators, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE ONE

**NAME:** The name of the Corporation is TIGHTLINE LOGGING, INC.

ARTICLE TWO

**PURPOSES:** The purpose of the Corporation is to conduct salvage logging operations on federal, state and private lands; to bid on and contract regarding such salvage operations, and to conduct and pursue general logging operations, including harvesting and hauling of logs and other forest products, and related business activity. The Corporation may further engage in any and all lawful business for which corporations may be organized under the Idaho Business Corporation Act.

ARTICLE THREE

**DURATION:** The period of duration of this Corporation is perpetual.

#### ARTICLE FOUR

**REGISTERED OFFICE AND REGISTERED AGENT:** The address of the Corporation's initial registered office in the State of Idaho is HC 01, Box 258, (St. Maries River Road), City of St. Maries, County of Benewah, State of Idaho 83861. The Corporation's initial registered agent at such address is Stanley Herrington.

#### ARTICLE FIVE

**STOCK:** The total authorized number of par value shares of stock is Ten Thousand (10,000) shares. The aggregate par value of the total authorized number of par value shares is One Hundred Thousand Dollars (\$100,000.00).

#### ARTICLE SIX

**TRANSFER OF STOCK:** In case a stockholder desires to sell his or her shares of stock, the stockholder must first offer them for sale to the remaining stockholders, it being the intention to give them a preference in this purchase of such shares, and any attempted sale in violation of this provision is null and void.

A stockholder desiring to sell his or her stock shall file notice in writing of the stockholder's intention with the secretary of the Corporation, stating the terms of sale, and unless the stockholder's terms are accepted by any or all other stockholders within thirty (30) days thereafter, they

shall be deemed to have waived their privilege of purchasing and the stockholder will be at liberty to sell to anyone else.


#### ARTICLE SEVEN


