ARTICLES OF INCORPORATION
OF

I, the undersigned natural person of the age of 21 years or more, acting as incorporator under the Idaho Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE I. The name of the corporation is DAVECO ENTERPRISES, INC., and its duration shall be perpetual.

ARTICLE II. The initial registered office of the corporation in the State of Idaho is 700 Samson Trail, McCall, Idaho 83633, and the initial registered agent for the corporation is DAVE BIER.

ARTICLE III. The purpose and powers of the corporation are:

1. To engage in the business of property management and property development.

2. To engage in any lawful activity for which corporations may be organized under Idaho Code, Chapter 30.

3. To engage in any lawful activity and to do anything in the operation of this corporation or for the accomplishment of any of its purposes or for the exercise of any power herein set forth which shall appear necessary or beneficial to this corporation in connection therewith.

ARTICLE IV. The amount of total authorized capital of this corporation shall be:

1. 500 shares of common stock at no par value.

2. No shareholder shall have the preferential or preemptive right to subscribe for or purchase any stock of any class, any rights, warrants or options with respect thereof, or any obligation convertible unto or exchangeable for any such stock or other security whether out of unissued stock or other securities or out of stock or other securities acquired by the corporation after the issue thereof, regardless of the consideration therefor.

3. Each shareholder shall have one vote for each share held of record on all matters submitted for shareholder approval. No shareholder shall be entitled to cumulate his votes for election of directors.

ARTICLE V. The members of the governing board shall be known as directors, and the number thereof shall be fixed by the bylaws of this corporation. The initial board of directors shall consist of (1) director, whose name and address are:

ARTICLE VI. The corporation shall indemnify, exonerate, reimburse or defend any presenter, former director, officer, employee, affiliate, agent or contractor of this corporation for expenses, claims, liabilities, indebtedness, penalties, damages or injury incurred by or caused by them in such capacity, except for their own negligence, knowing unauthorized acts or defalcations not ratified, confirmed or adopted or the benefit thereof received by this corporation.

ARTICLE VII. No shares of stock of this corporation shall be transferred by any shareholder other than in conformance with the

provisions of the bylaws and the buy-sell agreement executed by and between the shareholders of this corporation.
