

ARTICLES OF AMENDMENT

'86 DEC 23 AM 10 22

Articles of Amendment of the Articles of Incorporation of Greenco II, Inc. are executed by the corporation, pursuant to the provisions of Sections 30-1-61 and 30-1-62 of the Idaho Code.

SECRETARY OF STATE

I.

The name of the corporation is Greenco II, Inc.

II.

The amendment to the Articles of Incorporation of the corporation is as follows:

The number of capital shares of this corporation shall be 500,000 divided into two classes of shares, voting common and non-voting common.

There shall be 10,000 shares of voting common, each having the par value of \$0.10 per share. The voting common shares shall be voting shares, each share to entitle the holder to one vote.

There shall be 490,000 shares of non-voting common, each having the par value of \$0.10 per share. The non-voting common shares shall not entitle the holder to vote upon any subject. However, upon redemption by the corporation of all outstanding voting common shares, the non-voting common shares shall become voting shares, each share to entitle the holder to one vote.

Except for the differences provided by these Articles of Amendment, there shall be no difference between the two classes of shares as to preference, limitations, or rights.

III.

The date of the adoption of said amendment by the shareholders of said corporation is December 12, 1986.

IV.

The number of shares outstanding of the corporation is 500,000 shares.

The number of shares entitled to vote on the Amendment was 10,000.

V.

The number of shares voted for and against the Amendment, respectively, were as follows:

For Amendment:	10,000 shares
Against Amendment:	0 shares

VI.

The Amendment does not affect a change in the amount of the corporation's stated capital.
