CERTIFICATE OF AMENDMENT TO THE ARTICLES OF  
INCORPORATION

Everett Will Tractor Company, Inc., a Corporation of the State of Idaho, whose registered office is located at 218 North Main Street, Moscow, Idaho, Latah County, Idaho, certifies pursuant to written consent of all the stockholders for the corporation that it was agreed that the first paragraph of Article II of the Articles of Incorporation of the Everett Will Tractor Company, Inc., shall be amended to read as follows, to-wit:

FIRST PARAGRAPH OF ARTICLE II

The object for which said corporation is formed shall include, but not be limited to the manufacturing, construction, buying, selling, licensing, dealing in and dealing with machinery of every kind and description, and articles of every nature, and more particularly, agricultural machinery, farm machinery, dairy machinery, elevating and conveying machinery, transmission machinery, including automotive and all parts thereof, and to acquire, hold, possess and own letters patent of the United States and of any foreign country now or thereafter issued or to acquire licenses under such patents for the manufacture and sale of machinery or improvements thereon or articles of any nature, and beneficially to use rights under such patent by vending the said patents or rights and licenses thereunder; to manufacture as herein specified, either directly or indirectly, or by contract with other corporations or with individuals; and for the better attainment for the general purposes thus indicated to do everything necessary and expedient for the accomplishment of the corporate purposes, and with the further right and authority to engage in the business of insurance.




