of the "Twin Falls Placer Mining Company."

Whereas all men by these presents: —

That we the under-
signed have this day voluntarily associated
ourselves together for the purpose of forming
a corporation under the laws of the State
of Idaho, —

And we hereby certify, —
First, That the name of said Corporation is
"The Twin Falls Placer Mining Company";
Second, That the purposes for which it is
formed are to carry on the business of
mining for gold on Gravel River in the
State of Idaho, and acquiring by location
or purchase or otherwise, mining claims
and water rights, and to sell and lease, or
otherwise convey its privileges, franchises
and rights so acquired.

Third, That the place where its principal
business is to be transacted shall be the
town of Hiley, Blaine County, State of
Idaho, —

Fourth: That the term for which it is to
exist is Fifty years from and after the
date of its incorporation. —

Fifth: That the number of its directors
shall be eight, and that the names ^{and}
