ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS:

For the purpose of forming a corporation under the laws of the State of Idaho, the undersigned incorporators hereby Certify and agree as follows:

I - NAME

The name by which the corporation shall be known is:

SPRINKLER HILL PRODUCE, INC.,

II - LOCATION

The principal office of the corporation for the transaction of the business thereof shall be at Ririe in the County of Jefferson, State of Idaho;

III - TERM

The period of time for which this corporation is intended to exist is:

Perpetual.

IV - PURPOSES

The purposes and objects for which this corporation is being formed and for the accomplishment of which it is intended to exist, are as follows:

1. to engage in the handling of potatoes, buying, selling, processing, storing, etc.

2. to acquire and hold property, both real and personal, and mixed, and interests therein, and to sell, lease, mortgage or otherwise dispose of real or personal property as may seem necessary or convenient for the carrying out of the main purpose above mentioned.

3. To do any and all other things that might seem necessary, proper or convenient to the accomplishment of the said main purpose first above mentioned.

V - CAPITAL STOCK

The authorized capital stock three hundred shares having a par value of \$100.00 per share, and each share of which shall carry with it to its purchaser equal voting rights and other participating rights in


