## ARTICLES OF INCORPORATION

## R.L. SHOOK LOGGING, INC.

I.

I, the undersigned, being a natural person of full age, a citizen of the United States, or of its territories or possessions, do hereby voluntarily form a private corporation, under the laws of the STATE OF IDAHO.

II.

The name of the proposed corporation is R.L. Shook Logging, Inc.

III.

The period of its duration is perpetual.

IV.

The location and address of the registered office of this corporation shall be Box 645, Bovill, Idaho 83806.

V.

The registered agent of the corporation shall be Robert L. Shook of Box 645, Bovill, Idaho 83806.

VI.

The purpose of the corporation is the transaction of any or all lawful business for which corporations may be incorporated under this act.

VII.

The stock to be issued by this corporation shall be One Dollar (\$1.00) par value common stock.
