ARTICLES OF AMENDMENT TO O ARTICLES OF INCORPORATION

OF

Articles of Amendment of the Articles of Incorporation of MOSCOW CLINIC, INC., PROFESSIONAL ASSOCIATION, are herein executed by said Corporation, pursuant to the provisions of Section 30-1-59, et seq., of the Idaho Business Corporation Act, as follows:

- 1. The name of the Corporation is MOSCOW CLINIC, INC., PROFESSIONAL ASSOCIATION.
- 2. The amendment to the Articles of Incorporation of said Corporation is as follows:

ARTICLE I shall be amended to read as follows:

"The name of this Corporation shall be 'MOSCOW CLINIC, P.A.,' and its existence shall be perpetual."

ARTICLE VI shall be amended to read as follows:

"The number of Directors of this Corporation shall be fixed in the Bylaws and may be changed from time to time by amending the Bylaws."
