ARTICLES OF INCORPORATION

OF

DAVIS-SUPPLY COMPANY, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, all of whom are citizens of the United States, over the age of twenty-one years, have this day voluntarily associated ourselves together with the purpose of forming a corporation under the laws of the state of Idaho, and we hereby certify:

I

That the name of the corporation shall be Davis Supply Company, Inc.

II

That the purposes for which it is formed shall be to carry on the trade or business of buying and selling hardware, consisting of mining equipment, tools, and supplies, and farming implements, tools, and supplies, and general contractors' equipment, tools, and supplies, and sawmill equipment, tools, and supplies, and roofing, spouting, plumbing, heating, lighting, ventilating, electric, and builders' supplies, and gardening and landscaping equipment, tools, and supplies, and paint and painters' tools and supplies; and to buy and sell sporting goods and ammunition, and any and every kind of equipment, tools, and supplies incident to a hardware business or related thereto; also to contract with persons, firms, and corporations for equipping all manner of buildings or structures or premises with any of said equipment, tools, and supplies, and to conduct and carry on said businesses alone and/or with others as copartners or joint adventurers or otherwise.

The corporation shall have power to do and perform all or any of the acts and things enumerated in the General Corporation Law of the State of Idaho that private corporations are authorized to do, and have and exercise any further power hereafter conferred by law upon private corporations.

The corporation shall have power and authority to conduct business in any state, district, territory, or colony of the United States and foreign countries, and to have one or more offices and places of business outside the state of Idaho; and to acquire, receive, hold, purchase, lease, mortgage, dispose of, and convey real and personal property situated outside the state of Idaho; and it shall have the capacity to act in the premises possessed by natural persons.

III

Its duration shall be perpetual.

IV

The location and post-office address of its registered office in the state of Idaho shall be Boise City, Ada County, State of Idaho.

V

The total authorized number of par value shares is 2,500, and their aggregate par value is \$250,000.00.
