**Operating Provisions**





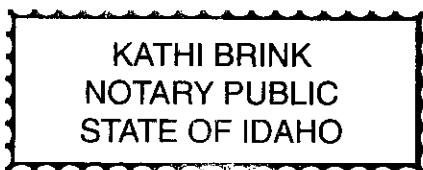
