## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION

OF

#### BLUE LAKES COUNTRY CLUB, INC.

Pursuant to the provisions of Sections 30-1-58 through 30-1-61 of the Idaho Business Corporation Act, BLUE LAKES COUNTRY CLUB, INC., adopts the following Articles of Amendment to the Articles of Incorporation, as previously amended:

- 1. The name of the corporation is Blue Lakes Country Club, Inc.
- 2. The following amendment to Article V of the Articles of Amendment to the Articles of Incorporation of Blue Lakes Country Club, Inc., dated March 8, 1981, was duly adopted by the equity members of the corporation on the 19th day of August, 1987, in the manner prescribed by the Idaho Business Corporation Act;

#### "ARTICLE V MEMBERS

The corporation shall have two classes of membership, equity membership and non-equity membership, and the rules and regulations with respect to admission of members to either class of membership shall be established by the Board of Directors in accordance with the criteria set forth in the By-Laws. Each equity membership shall be issued a share of capital stock authorized by Article VIII herein and conformance therewith shall be entitled to one (1) vote. Non-equity memberships shall be non-voting memberships. Unless otherwise expressly stated, all references to "member" "members" in these Articles By-Laws shall refer to owners or holders of equity memberships."

3. The number of equity shares of capital stock outstanding of the corporation are 375, and all of the aforesaid shares are entitled to vote on the referenced amendment.

4. The aforesaid amendment was passed and adopted by the equity membership at the special meeting referred to in paragraph 2 above, by a vote of 87 in favor and 5 against.
