The undersigned incorporators, desiring to form a namerofit corporation pursuant to the provisions of the Idaho Nonprofit Corporation Act, adopt the following Articles of Incorporations

OF

ARTICLE ONE: The name of the Corporation is ARCO/BUTTE BUSENESS INCUBATION CENTER, INC.

The purpose of the Corporation is to promote ARTICLE TWO: local economic development and further social welfare by operating a small business incubator that will provide small, start-up businesses with operating space and management counseling and support, at below market rates. This purpose shall be fulfilled by providing assistance to businesses meeting one of the following criteria:

- a. business enterprises located in an economically depressed area, which could not obtain funds from conventional commercial sources;
- businesses that will provide training and employment opportunities for the unemployed or underemployed residents of the area:
- c. businesses that will locate in a deteriorated area solely because of the proposed assistance; or
- businesses having initial requirements for low-skilled d. workers.

This Corporation is organized exclusively for charitable purposes, and shall restrict its activities to those not proscribed by §501(c)(3) of the IRS Code.

The period of duration of the Corporation is ARTICLE THREE: perpetual.

The number of Directors constituting the ARTICLE FOUR: initial Board of Directors is five, and the names and addresses of the persons who are to serve as Directors until the first annual meeting of the Corporation, or until their successors are elected and qualify, are as follows:
