The undersigned, a natural person over the age of eighteen (18) years, and legally authorized to practice dentistry within the state of Idaho, does hereby form a professional corporation under the laws of the state of Idaho, as contained in Chapter 13 of Title 30 of the Idaho Code, entitled "Professional Service Corporation Act," for the purpose of practicing dentistry, and to that end do hereby certify:

FIRST: The name of the corporation is MARK A. PLANT, D.D.S., P.A.

SECOND: The purpose for which the corporation is formed is to engage in the general practice of dentistry and to have and to exercise all the powers now or hereafter conferred by the laws of the State of Idaho upon corporations organized pursuant to the laws under which the corporation is organized and any and all acts amendatory thereto and supplemental thereto.

THIRD: The aggregate number of shares which the corporation shall have authority to issue is 1,000 shares, all of which are to be common voting stock without par value.

FOURTH: The address of the initial registered office of the corporation is 590 Falls Avenue, Twin Falls, Idaho 83301, and the name of its initial registered agent at such address is Mark A. Plant, D.D.S.

FIFTH: The name of the incorporator is Mark A. Plant, D.D.S. and address of the incorporator is 590 Falls Avenue, Twin Falls, Idaho 83301.

SIXTH: The shareholders are authorized to adopt Bylaws restraining the alienation of shares and providing for the purchase or redemption by the corporation of its shares; provided, however, such provisions dealing with the purchase or redemption by the corporation of its shares may not be invoked at a time or in a manner that would impair the capital of the corporation.
