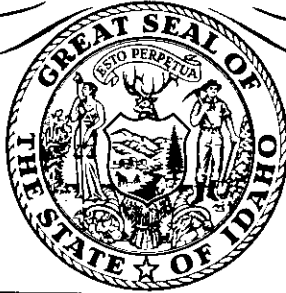

1 ARTICLES OF INCORPORATION

3 WESTERN DRYER, INC.

5 KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned
6 citizens of the United States of America, and of the State of
7 Idaho, over the age of twenty-one years, do hereby voluntarily
8 associate ourselves together for the purpose of forming a corpora-
9 tion under the laws of the State of Idaho, and we do hereby make,
10 sign, acknowledge and file this certificate for that purpose, as
11 follows:
12

13 ARTICLE ONE

14 The name of this corporation shall be:

15 WESTERN DRYER, INC.

16 This corporation shall have perpetual existence.
17

18 ARTICLE TWO

19 In order to effectuate the objects and purposes herein
20 declared to be the purposes for which this corporation is
21 organized, it is formed and is authorized to do as principal
22 agent, or otherwise, in any and every part of the world, any and
23 everything herein set forth to the same extent as natural persons
24 might and could do. In furtherance of, and not in limitation of
25 the general powers conferred by the laws of the State of Idaho, it
26 is hereby expressly provided that this corporation shall have the
27 following powers:
28

29 (1) To conduct a general machine shop business of
30 every kind and character, on a cash, credit or commission basis,
31 or on partly a cash and partly a credit basis; to apply for, buy,
32

1 acquire, secure, own and transfer machine shop equipment, parts
2 and supplies of every kind and character; to build, manufacture and
3 repair tools, machinery and equipment; to buy, sell, lease, rent,
4 build, and dispose of goods, wares and merchandise of every kind
5 and character; to enter into, carry out, and perform contracts of
6 every kind and character; to enter into and perform agency contracts;
7 to give, take, accept, buy, sell, endorse, guarantee, negotiate
8 and assign conditional sales contracts, notes, commercial paper,
9 and any and all other evidences of indebtedness;
10

11 (2) To buy, own, lease, operate and sell machine shops,
12 equipment, trucks, vehicles, plants, stores, yards and vans of
13 every kind and character;
14

15 (3) To own, operate, build, construct, fit, equip,
16 furnish, purchase and operate machinery, machine shops, trucks,
17 vans, vehicles, stores, warehouses, plants and yards, and any and
18 all other facilities intended to be used, or to be used for the
19 conduct of, or in the conduct of a general machine shop business;
20

21 (4) To borrow money for corporate purposes, and to
22 issue therefor notes, bonds, debentures and other evidences of
23 indebtedness;

24 (5) To engage in, conduct, and carry on the business of
25 repairing, manufacturing, buying and selling machinery, and
26 personal property of every kind and description, and to furnish
27 and supply any and all articles useful or desirable in conducting
28 a general machine shop business, and in connection therewith to
29 own and operate trucks, vans, vehicles, warehouses, stores,
30 plants and facilities, and any and every other facilities in
31 connection therewith;

1 (6) To furnish facilities for, and to engage in the
2 business of operating machine shops, and to own and use therefor
3 machines, tools, supplies, parts, equipment, trucks, plants, vans,
4 cars, docks and vehicles of every kind and character;

5
6 (7) To contract for, buy, sell, own, and operate means
7 of manufacturing of any and all kinds whatsoever;

8 (8) To buy, sell, lease, mortgage, own and consolidate
9 with Machinery Companies of every kind and character;

10 (9) To construct, erect and operate shops, warehouses,
11 stores, plants, and any other buildings or structures or improvements
12 in anywise appertaining thereto;

13
14 (10) To take, hold, lease, mortgage, own, purchase, or
15 acquire by operation of law, or otherwise, real property, or any
16 interest therein, or appurtenant thereto, including store rooms,
17 shop equipment houses, stations, warehouses, store buildings, and
18 any part thereof, or any interest therein, or to sell, lease,
19 exchange, mortgage or hypothecate real estate, or any interest
20 therein, and to engage in any and all undertakings and business
21 necessary and proper to the improvement and betterment of any of
22 the land or real property owned or to be acquired by said corpora-
23 tion, or in any other lands in which the said corporation may have
24 any interest, and to handle and deal in any lands of said corpora-
25 tion in any manner it may desire;

26
27 (11) To enter into, make, perform and carry out contracts
28 of every kind, amount and character with any person, firm, asso-
29 ciation or corporation;

30
31 (12) To purchase, own, sell, convey, mortgage, pledge,
32 exchange, acquire by operation of law, or otherwise, personal

1 property of every kind and character, debts, dues and demands,
2 choses of action, or patents, and each and every kind of personal
3 property, evidences of debts, bonds, and stocks of this and other
4 corporations, both public and private, which the corporation may
5 deem necessary and convenient for its business or otherwise;
6

7 (13) To borrow and lend money from and to any person,
8 firm, association or corporation, and to make, take and execute
9 notes, debentures, bonds, mortgages, deeds of trust, or other
10 evidences of indebtedness to secure payment thereof, or by any
11 other lawful manner or means, and to take and receive notes,
12 debentures, bonds, mortgages, deeds of trust, or any evidences of
13 indebtedness for the use and benefit of said corporation, or
14 otherwise;
15

16 (14) To acquire, retain, deal in and retire its own
17 corporate stock insofar as it is lawful for it so to do;
18

19 (15) To own, hold, lease, or sublet, or to conduct on
20 its own account, or for any person, firm, association or corpora-
21 tion, all and every kind of merchandise, business or pursuit
22 necessary or proper to carry on the business of said corporation;
23

24 (16) To build and operate any and all necessary shops,
25 buildings, store rooms, warehouses and structures at any place
26 proper or convenient to carry on any or all of the business of
27 said corporation;
28

29 (17) In addition to the foregoing powers, to also have
30 all authority, power or right granted to corporations by the
31 Constitution or laws of the State of Idaho and any amendments
32 thereto;

1 (18) To do and perform every act and thing necessary
2 to carry out the above enumerated purposes, or calculated directly
3 or indirectly to the advancement of the interests of the corpora-
4 tion, or to the enhancement of the value of its stocks, holdings
5 and property of any kind or character.

7 ARTICLE THREE

9 The registered office of this corporation in Idaho is
10 hereby fixed at Boise City, Ada County, Idaho. The registered
11 office of this corporation may be changed from time to time by
12 action of the Board of Directors of this corporation.

14 ARTICLE FOUR

15 The number of Directors of this corporation shall be
16 four (4).
17

18 ARTICLE FIVE

19 The amount of capital stock of this corporation is
20 TWO HUNDRED FIFTY THOUSAND DOLLARS (\$250,000.00), divided into
21 Two Hundred Fifty Thousand (250,000) shares, each of the par value
22 of ONE DOLLAR (\$1.00). The said capital stock shall be non-
23 assessable.

25 ARTICLE SIX

26 The private property of the shareholders of this
27 corporation shall not be subject to the payment of corporation
28 debts of this corporation.
29

30 ARTICLE SEVEN
