ARTICLES OF INCORPORATION

<u>OF</u>

WESTERN DRYER, INC.

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned citizens of the United States of America, and of the State of Idaho, over the age of twenty-one years, do hereby voluntarily associate ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we do hereby make, sign, acknowledge and file this certificate for that purpose, as follows:

ARTICLE ONE

The name of this corporation shall be:

WESTERN DRYER, INC.

This corporation shall have perpetual existence.

ARTICLE TWO

In order to effectuate the objects and purposes herein declared to be the purposes for which this corporation is organized, it is formed and is authorized to do as principal agent, or otherwise, in any and every part of the world, any and everything herein set forth to the same extent as natural persons might and could do. In furtherance of, and not in limitation of the general powers conferred by the laws of the State of Idaho, it is hereby expressly provided that this corporation shall have the following powers:

(1) To conduct a general machine shop business of every kind and character, on a cash, credit or commission basis, or on partly a cash and partly a credit basis; to apply for, buy,

acquire, secure, own and transfer machine shop equipment, parts and supplies of every kind and character; to build, manufacture and repair tools, machinery and equipment; to buy, sell, lease, rent, build, and dispose of goods, wares and merchandise of every kind and character; to enter into, carry out, and perform contracts of every kind and character; to enter into and perform agency contracts; to give, take, accept, buy, sell, endorse, guarantee, negotiate and assign conditional sales contracts, notes, commercial paper, and any and all other evidences of indebtedness;

- To buy, own, lease, operate and sell machine shops, equipment, trucks, vehicles, plants, stores, yards and vans of every kind and character;
- To own, operate, build, construct, fit, equip, **(**3) furnish, purchase and operate machinery, machine shops, trucks, vans, vehicles, stores, warehouses, plants and yards, and any and all other facilities intended to be used, or to be used for the conduct of, or in the conduct of a general machine shop business;
- (4) To borrow money for corporate purposes, and to issue therefor notes, bonds, debentures and other evidences of indebtedness;
- To engage in, conduct, and carry on the business of (5) repairing, manufacturing, buying and selling machinery, and personal property of every kind and description, and to furnish and supply any and all articles useful or desirable in conducting a general machine shop business, and in connection therewith to own and operate trucks, vans, vehicles, warehouses, stores, plants and facilities, and any and every other facilities in connection therewith;

(6) To furnish facilities for, and to engage in the				
business of operating machine shops, and to own and use therefor				
machines, tools, supplies, parts, equipment, trucks, plants, vans,				
cars, docks and vehicles of every kind and character;				
(7) To contract for, buy, sell, own, and operate means				
of manufacturing of any and all kinds whatsoever;				

- (8) To buy, sell, lease, mortgage, own and consolidate with Machinery Companies of every kind and character;
- (9) To construct, erect and operate shops, warehouses, stores, plants, and any other buildings or structures or improvements in anywise appertaining thereto;
- acquire by operation of law, or otherwise, real property, or any interest therein, or appurtenant thereto, including store rooms, shop equipment houses, stations, warehouses, store buildings, and any part thereof, or any interest therein, or to sell, lease, exchange, mortgage or hypothecate real estate, or any interest therein, and to engage in any and all undertakings and business necessary and proper to the improvement and betterment of any of the land or real property owned or to be acquired by said corporation, or in any other lands in which the said corporation may have any interest, and to handle and deal in any lands of said corporation in any manner it may desire;
- (11) To enter into, make, perform and carry out contracts of every kind, amount and character with any person, firm, association or corporation;
- (12) To purchase, own, sell, convey, mortgage, pledge, exchange, acquire by operation of law, or otherwise, personal

property of every kind and character, debts, dues and demands, choses of action, or patents, and each and every kind of personal property, evidences of debts, bonds, and stocks of this and other corporations, both public and private, which the corporation may deem necessary and convenient for its business or otherwise;

- To borrow and lend money from and to any person, (13)firm, association or corporation, and to make, take and execute notes, debentures, bonds, mortgages, deeds of trust, or other evidences of indebtedness to secure payment thereof, or by any other lawful manner or means, and to take and receive notes, debentures, bonds, mortgages, deeds of trust, or any evidences of indebtedness for the use and benefit of said corporation, or otherwise;
- To acquire, retain, deal in and retire its own corporate stock insofar as it is lawful for it so to do;
- (15) To own, hold, lease, or sublet, or to conduct on its own account, or for any person, firm, association or corporation, all and every kind of merchandise, business or pursuit necessary or proper to carry on the business of said corporation;
- To build and operate any and all necessary shops, buildings, store rooms, warehouses and structures at any place proper or convenient to carry on any or all of the business of said corporation;
- In addition to the foregoing powers, to also have all authority, power or right granted to corporations by the Constitution or laws of the State of Idaho and any amendments thereto;

(18) To do and perform every act and thing necessary to carry out the above enumerated purposes, or calculated directly or indirectly to the advancement of the interests of the corporation, or to the enhancement of the value of its stocks, holdings and property of any kind or character.

ARTICLE THREE

The registered office of this corporation in Idaho is hereby fixed at Boise City, Ada County, Idaho. The registered office of this corporation may be changed from time to time by action of the Board of Directors of this corporation.

ARTICLE FOUR

The number of Directors of this corporation shall be four (4).

ARTICLE FIVE

The amount of capital stock of this corporation is TWO HUNDRED FIFTY THOUSAND DOLLARS (\$250,000.00), divided into Two Hundred Fifty Thousand (250,000) shares, each of the par value of ONE DOLLAR (\$1.00). The said capital stock shall be nonassessable.

ARTICLE SIX

The private property of the shareholders of this corporation shall not be subject to the payment of corporation debts of this corporation.
