ARTICLE I

The name of this corporation shall be Wally and Nita Lovan Scholarship Foundation, Inc.

ARTICLE II

This corporation is a nonprofit corporation and shall have no capital stock and shall have no members.

ARTICLE III

The purposes of this corporation are as follows:

- To provide scholarships for needy college students, and to collect money therefor.
- This organization is organized exclusively for charitable purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code.

ARTICLES OF INCORPORATION

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue law) or (b) by a corporation contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law).

ARTICLE IV

The period of existence and duration of this corporation shall be perpetual.

ARTICLE V

The location and street address and principal office of this corporation shall be 4200 W. Talamore, Meridian, Idaho, and the name of the initial registered agent of said corporation shall be Jennifer Lovan-Holloway.

ARTICLE VI

Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code (or corresponding section of any future tax code), or shall be

distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by the District Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
