## TENSED AMBULANCE SERVICE, INCORPORATED

#### ARTICLES OF INCORPORATION,

The undersigned, all of whom are citizens of the United States, desiring to form a non-profit corporation under the provisions of the non-profit corporation law of the State of Idaho, do hereby adopt the following Articles of Incorporation:

#### ARTICLE I: Name

The name of the corporation shall be TENSED AMBULANCE SERVICE, INCORPORATED.

#### ARTICLE II: Location/Address

The principle office of the corporation shall be located in the City of Tensed, Benewah County, Idaho. The initial address of the corporation shall be Post Office Box #6, Zip 83870.

#### ARTICLE III: Duration

The duration of the corporation shall be perpetual.

#### ARTICLE IV: Purpose

The corporation is organized primarily to further the common good and general welfare of the people of the community within the meaning of Section 501 (c) (4) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Revenue Law, by voluntarily providing emergency medical services, transportation and life-support systems.

#### ARTICLE V: Incorporators

The names and addresses of the persons who are the incorporators and initial directors of the corporation are as follows:

The official Registered Agent of the corporation is Ms. Thelma Johnson.

# ARTICLE VI: Provisions for Regulation and Conduct of the Affairs of the Corporation

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered, and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on the behalf of a candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under Section 501 (c) (4) of the Internal Revenue Law, of (b) by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

### ARTICLE VII: Dissolution of the Corporation

Upon the dissolution of the corporation, the Board of Trustees shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such charitable, educational, religious, or scientific organizations as shall at the time qualify as an exempt organization or organizations under Section 501 (c)(4) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Trustees shall determine. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated for such purposes.
