

STATEMENT OF AMENDMENT OF ARTICLE 2 OF THE ARTICLES OF
INCORPORATION OF THE SALMON RIVER RAILROAD COMPANY,
A CORPORATION OF THE STATE OF IDAHO.

O. H. Jones, Chairman, and G. L. Smith, Secretary
of the special meeting of the stockholders of the Salmon
River Railroad Company, held at the office of the Superin-
tendent of the Montana Division of the Oregon Short Line
Railroad Company, at Coeur d'Alene, Idaho County, Idaho, at
ten o'clock A.M. on the 21st day of May, 1909, for the
purpose of amending Article 2 of the Articles of Incorpora-
tion of the said Company, and J. H. Bancroft, F. M. Davis,
John G. Brown and G. L. Smith, members and constituting a
majority of the board of directors of the said corporation
do hereby certify that on the 4th day of May, 1909, by a
majority vote of the board of directors of said Salmon River
Railroad Company, a corporation, at a meeting of said board
 duly called and held, a resolution was passed authorizing
and directing a special meeting of the stockholders of said
corporation, to be held at the office of the Superintendent of
the Montana Division of the Oregon Short Line Railroad
Company at Coeur d'Alene, Idaho County, Idaho, at ten o'clock A.M.,
on the 21st day of May, 1909, for the purpose of consider-
ing and adopting an amendment to Article 2 of the Articles
of Incorporation of the said company. That notice of the
time and place of holding said stockholders' meeting and
the objects thereof was published at Coeur d'Alene, Idaho
County, Idaho, where the principal place of business of
said Salmon River Railroad Company is situated, for a period

of two weeks prior to the said 21st day of May, 1909, the day fixed for said meeting.

That the said notice also contained a statement of the nature of the amendment proposed to said Article II of the Articles of Incorporation of said Company.

That at the time and place specified in said notice, said stockholders' meeting was held. That all of the shares of stock of said corporation issued and outstanding there were present and represented at said meeting 1498, being all of the said shares so issued and outstanding, except 2; and at said meeting all of said shares so present and represented voted in favor of the proposed amendment of the said Article II, and there was no votes cast against such amendment.

That more than two-thirds of the entire capital stock of the Salmon River Railroad Company so subscribed, issued and outstanding voted in favor of the said amendment. The said amended Article as proposed at said meeting is in the language following, to-wit:

ARTICLE II.

The purpose for which this corporation is organized is to construct, own, maintain and operate a railroad and telegraph and telephone lines with such branch lines and extensions as may from time to time be deemed desirable and as may be authorized by law. The said railroad, telegraph and telephone lines are to begin at the town of Blackfoot, on the Oregon Short Line Railroad, in Lingham County, state of Idaho, and extend thence in a general northwesterly direction to a point on Big Lost River, in or near section Twenty-eight (28), township seven (7) North, range twenty-four (24) east of the Boise Meridian, in Bitter County in said state, a distance of ninety-five (95) miles, more or less. Also a branch line of railroad with telegraph and

telephone lines beginning at a point on the present main line of said company, as now constructed, about seven (7) miles westerly from the said town of Blackfoot and near the town of Moreland, in said Bingham County, and extending thence in a southwesterly direction on the westerly side of Snake River and passing through the town of Aberdeen to a point of connection with the Oregon Short Line Railroad at or near the town of American Falls, Oneida County, State of Idaho, a distance of forty (40) miles, more or less; the entire length of said main and branch lines being one hundred thirty-five (135) miles, more or less, and situated within the counties of Bingham, Blaine, Custer and Oneida in said state. Said lines of railroad, or any part thereof, may be operated by steam or electrical power as the said company may from time to time determine."

That W. H. Jones was Chairman of said stockholders' meeting and G. K. Smith was the Secretary thereof.

That the undersigned, W. H. Pancroft, J. M. Davis, John G. Brown and G. K. Smith, are members of the Board of Directors of the Salmon River Railroad Company and constitute a majority of said board, the entire board consisting of five (5) members.
