# KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being natural persons of legal age, and at least two-thirds of them being citizens of the United States, in order to form a corporation for the purposes hereinafter stated pursuant to the Business Corporation Act of Idaho, do hereby certify as follows: FIRST:

The name of the corporation is ROBBINS BUILDERS INC. SECOND:

The purposes for which said corporation is formed are:

To carry on and conduct a general engineering, contracting and construction business, including therein the designing, construction business, including therein the designing, constructing, enlarging, repairing, remodeling, renovating or otherwise engaging in any work upon buildings, including but not limited to residentual, commercial, industrial or public buildings, and all rock, wood, masonry, cement, steel, glass, aluminum, plastic, and any and all other building materials or combinations thereof, for construction incident thereto and to extend and receive any contracts or assignments of contracts therefore or in relation thereto or connected therewith and to manufacture, sell and furnish all building materials and supplies connected therewith.

SIXTH:

FILLED BY THE REMAINING MEMBERS OF SAID BOARD. ON FAILURE

OF THE BOARD TO ELECT, A SPECIAL MEETING OF THE STOCKHOLDERS

SHALL BE CALLED TO FILL THE VACANCY.

### EIGHTH:

THE EXISTENCE OF THIS CORPORATION IS TO BE PERPETUAL.

NINTH:

THE DIRECTORS SHALL HAVE THE POWER TO MAKE AND TO ALTER OR AMEND THE BY-LAWS, TO FIX THE AMOUNT TO BE RESERVED AS WORKING CAPITAL AND TO AUTHORIZE AND CAUSE TO BE EXECUTED MORTGAGES AND LIENS WITHOUT LIMIT AS TO THE AMOUNT UPON THE PROPERTY AND FRANCHISE OF THIS CORPORATION.

#### TENTH:

This corporation shall indemnify any and all of its DIRECTORS OR OFFICERS OR FORMER DIRECTORS OR OFFICERS OR ANY PERSON WHO MAY HAVE SERVED AT ITS REQUEST AS A DIRECTOR OR OFFICER OF ANOTHER CORPORATION IN WHICH IT OWNS SHARES OF CAPITAL STOCK OR OF WHICH IT IS A CREDITOR AGAINST EXPENSES ACTUALLY AND NECESSARILY INCURRED BY THEM IN CONNECTION WITH THE DEFENSE OF ANY ACTION, SUIT OR PROCEEDING IN WHICH THEY, OR ANY OF THEM, ARE MADE PARTIES, OR A PARTY, BY REASON OF BEING OR HAVING BEEN DIRECTORS OR OFFICERS OR A DIRECTOR OR OFFICER OF THE CORPORATION, OR OF SUCH OTHER CORPORATION, EXCEPT IN RELATION TO MATTERS AS TO WHICH ANY SUCH DIRECTOR OR OFFICER OR FORMER DIRECTOR OR OFFICER OR PERSON SHALL BE ADJUDGED IN SUCH ACTION, SUIT OR PROCEEDING TO BE LIABLE FOR NEGLIGENCE OR MISCONDUCT IN THE PERFORMANCE OF DUTY.
