KNOW ALL MEN BY THESE PRESENTS, that the undersigned, for the purpose of amending the Articles of Incorporation of VALLEY LIFE COMMUNITY CHURCH, INC. pursuant to Section 30-1-1003 of the *Idaho Code*, do hereby certify, declare, and adopt the following Articles of Amendment:

I.

The current name of the corporation is VALLEY LIFE COMMUNITY CHURCH, INC.

II.

The corporation's Articles of Incorporation are hereby amended to add the following sentence to Article IX of the corporation's Articles of Incorporation:

"Notwithstanding anything to the contrary contained elsewhere in these Articles of Incorporation, Valley Life Community Church, Inc., is a member church in the Reformed Church in America; is (and at all times shall be) subject to and governed by the Constitution of the Reformed Church in America; and agrees that the provisions of these Articles shall not be amended or modified in any manner without the prior written consent of the classis of which Valley Life Community Church, Inc., is a member."

III.

The Articles of Incorporation for this corporation provide for neither membership, nor stockholders, of the corporation.


VII.

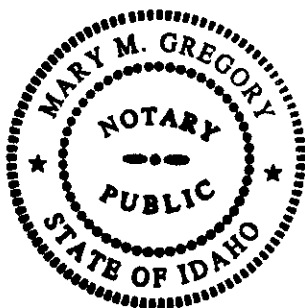
