and operating various logging
and hauling away or all metals
precious or otherwise and
to handle and reduce the same
thereof

Third That the principal place of
business of said Co shall be
at Applegate Idaho with branch
offices at Indianapolis Indiana
and Cincinnati Ohio

Fourth That the term for which it is
to exist is Fifty years from
and after the date

of its incorporation
Fifth That the number of its directors
