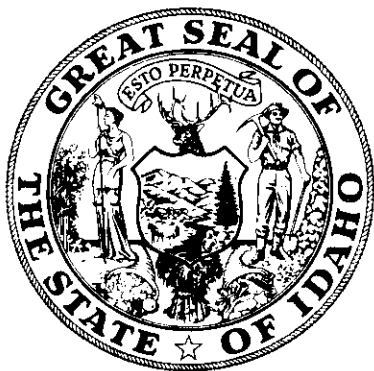

ARTICLES OF INCORPORATION
OF
FAMILY FURNITURE, INC.

The undersigned, acting as incorporations of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST

The name of the corporation is FAMILY FURNITURE, INC.

SECOND

The period of its duration is perpetual.

THIRD

The purpose or purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH

The aggregate number of shares which the corporation shall have authority to issue is FIFTY THOUSAND SHARES (50,000), each having a par value of ONE DOLLAR (\$1.00) per share, and an aggregate par value of FIFTY THOUSAND DOLLARS (\$50,000).

FIFTH

There are no provisions denying preemptive rights.

SIXTH

The address of the initial registered office of the corporation is - 1112 Main Street, Lewiston, Idaho, 83501, and the name of its initial registered agent at such address is James N. Soyk.

SEVENTH

The number of directors constituting the initial Board of Directors of the corporation is TWO (2), and the names and addresses of the persons who are to serve as directors until the first annual meeting of the shareholders, or until their successors are elected and shall qualify, are:




