### CERTIFICATE OF INCORPORATION

One Thousand Nine Hundred **Fifty-five** and duly recorded on Film No. **91** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 30-103, Idaho Code.

ARTICLES OF INCORPORATION  
of  
GORTSEMA MOTORS, INC.  
GRANGEVILLE, IDAHO

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, being natural persons of legal age, and citizens of the United States of America, and residents of the State of Idaho, have associated ourselves for the purpose of forming a business corporation pursuant to the provisions of the Business Corporation Act of the laws of the State of Idaho, for the purposes hereinafter set forth, and we do hereby certify to, and adopt the following articles of incorporation:

I

That the name of the corporation is: GORTSEMA MOTORS, INC.

II

That this corporation is formed and organized for the purposes of engaging in a general automotive and merchandising business, including, but not exclusively, the following specific purposes:

- A. To manufacture, buy, sell, rent, store, repair and care for automobiles, trucks, motorcycles, tractors, engines, boats, and all other types of motor vehicles and conveyances, and all types of machinery, appliances, parts, equipment and supplies related to, or used in connection therewith.
- B. To build, purchase, or otherwise acquire and operate automotive, and/or merchandising or manufacturing businesses, buildings, storage houses, warehouses and garages for the storing, repairing, caring for, and keeping therein of automotive vehicles, equipment and parts, and all types of merchandise of every kind and description.

- C. To buy, sell, and deal in all kinds of goods, wares, and merchandise. ✓
- D. To apply for, purchase, or otherwise acquire, and to grant licenses for the use of, to sell, assign, or otherwise deal in and use, patents, patent rights, privileges, licenses, trade marks, trade names, devices and improvements, or secret processes of every sort and description, necessary or incidental to the other purposes herein mentioned.
- E. To carry on a general manufacturing, wholesale and/or retail merchandising business.
- F. To do all things necessary and convenient to the operating, financing, and carrying on of the aforementioned businesses according to the intents and purposes of a general business of such nature, and in connection therewith to sell capital stock, and to issue and sell bonds, debentures, mortgages and other securities and evidences of debt, and to do all things legally necessary to finance said business operations, including the borrowing of money and giving security for the repayment thereof, and the making and entering into contracts and agreements for agencies, for the sale, distribution, servicing, transportation, financing and handling of the goods, wares, merchandise and property items to be dealt with and incidental to said business; To have and acquire real and personal property, and to dispose of the same; to have and exercise the power to do any and all things necessary in the operation of such business, and to use and enjoy all the power and authority granted by the laws of the State of Idaho relating to business corporations; and to do any and all things necessary and convenient to fully effectuate the intent and purposes of this incorporation. ✓

### III

This corporation shall have perpetual existence, except as it may be limited or terminated by, or in accordance with law.

### IV.

The location and post office address of the registered office of the corporation is Grangeville, Idaho County, Idaho.

### V.

The total authorized capital of the corporation shall be TWO HUNDRED THOUSAND DOLLARS, and the total number of par value shares of stock shall be Two Thousand, having an aggregate value of Two Hundred Thousand Dollars. The stock shall be in shares having a par value of One Hundred Dollars each, and all of the same shall be common stock, with each share having a voting power of one vote, without preference or restriction of any kind, or in any manner whatsoever.

### VI

The number of directors of this corporation shall be not less than three, but may be in any number in excess thereof as shall be determined and fixed by the By-laws of the corporation.

### VII

The Board of Directors, by a majority of its members, shall have the power to repeal or amend, or to adopt new By-Laws.

### VIII

The names and addresses of the directors who shall manage the affairs of the corporation for the remainder of the calendar year of 1955, and until their successors are elected and qualified, are as follows:
