

Re: Permission to Use the Names "Bank of the Cascades" and "Cascade Bancorp"

Dear Mr. Zink:

The Idaho Department of Finance (Department) received your letter, dated February 11, 2014, in which you request the Department's permission to use the word "bank" in the names of the business entities through which you conduct business in Idaho. The principal corporate entities are Bank of the Cascades and Cascade Bancorp.

Section 26-1202 of the Idaho Bank Act prohibits any person, other than a national bank, not authorized to operate as a bank or to conduct the business of banking under the Act, to advertise or use as part of its company name the word "bank" or "banker" or any other word of similar import. Bank of the Cascades and Cascade Bancorp have been authorized and continue to be authorized under the Act to operate as a bank and to conduct the business of banking in Idaho. The Department first granted the organizations permission to use the word "bank," as it appears in their names, on July 31, 2007. In view of this, Bank of the Cascades and Cascade Bancorp may continue to use the word "bank" in their business activities conducted in Idaho.
