


**CERTIFICATE OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is J. M. D. R. Water Slides, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue 100,000; par value \$5.00 per share.

FIFTH: The name and address of the initial registered agent and office of the corporation is John Johnson, Route 3, Box 207, Idaho Falls, Idaho 83401.






