We, the undersigned natural persons, acting as incorporators of a corporation under the Business Corporations Act of Idaho, adopt the following Articles of Incorporation for such corporation;

I

The name of this corporation is G & S Installation, Inc., and its principal place of business shall be at 367 Melrose, Idaho Falls, Idaho 83401. The registered agent of the corporation is Greg Birkinbine, whose registered office address is 1057 North Lee Avenue, Idaho Falls, Idaho 83402.

II

The corporation is to have perpetual existence.

III

The purpose or purposes for which the corporation is organized is to engage in and do any lawful act concerning any or all lawful businesses for which corporations may be organized under the Business Corporations Act of the State of Idaho.

Greg Birkinbine, as the initial Registered Agent for G & S Installation, Inc., an Idaho corporation, does hereby accept the appointment of Registered for said company.


