

The undersigned, in order to form a corporation for the purposes hereinafter stated, pursuant to the Idaho Business Corporation Act, as now in effect or as may hereafter be amended, do hereby certify as follows:

#### ARTICLE I

The name of the corporation is JORDAN-WILCOMB CONSTRUCTION, INC. ("Corporation").

#### ARTICLE II

The purpose for which this Corporation is organized is to engage in any lawful activity or business for which corporations may be incorporated under the Idaho Business Corporation Act.

#### ARTICLE III

The Corporation shall have perpetual existence.

#### ARTICLE IV

The address of the initial registered office of the Corporation is 406 South Sixth Street, Boise, Idaho 83702 and the name of its initial registered agent at such address is Timothy R. Wilcomb.

## ARTICLE V

The shares of stock to be issued by the Corporation shall consist of one class only, and the aggregate number of shares which the Corporation shall be authorized to issue shall be 50,000 shares of stock, each having a par value of \$1.00 per share. All shares of stock shall have the same rights in the Corporation and shall be nonassessable when paid in full.

## ARTICLE VI

The shareholders of the Corporation shall have a preemptive right to acquire unissued or treasury shares or securities convertible into, or carrying a right to acquire, shares of the Corporation, including the preemptive right to acquire shares of the Corporation sold otherwise than for cash.

## ARTICLE VII
