# DOCUMENT NO. 1

Resolution No. 1 Amendment of Section 28, Subparagraph 1
The State of the Order and Law Committees recommended:that
Section 28, Subparagraph 1 read as follows:

"1. The Trustees shall select a bank or banks or savings institution(s), whose deposits are insured by an agency of the United States government, as depository(ies) of Subordinate Lodge Funds. Up to fifty (50) percent of the general or a special fund of a lodge may be deposited in such an account in the A.O.U.W. Federal Credit Union."

# DOCUMENT NO. 2

Resolution No. 2 Descriptive Titles

The State of the Order and Law Committees recommended adoption of the following as a new section to Article I of the Constitution and Laws:

"Section 25 DESCRIPTIVE TITLES

To facilitate communication with persons unfamiliar with such officers in our Order, and completion of forms designed for the popular titles attributed to the same official responsibilities, the following references may be used: Supreme Master Workman (President); and Supreme Recorder (Secretary).

#### DOCUMENT NO. 3

Resolution No. 3 Amendment of Article I, Section 6

The State of the Order Committee recommended against emendment of Article I, Section 6 of the Constitution and Laws to change the frequency of Supreme Lodge Sessions to quadrennially rather than biennially.

#### DOCUMENT NO. 4

Resolution No. 4 Amendment of Article I, Section 3

The State of the Order and Law Committees recommended adoption of the following:

# Section 3 COMPOSITION-VOTING RIGHTS (new second sentence)

"If other members exceed in number one-half the elective representatives of subordinate lodges, the Credentials Committee shall report that fact and identify a number of such other members equal to one-half the representative members, as entitled to vote, in the following order of priority:

1. Supreme Master Workman

2. Supreme Trustees

3. Other current Supreme (elective) officers

4. Chairmen of Standing Committees

- 5. Past Grand or Supreme Master Workmen in good standing
- 6. Other appointive officers including members of standing committees according to length of membership in the Order.

# (last sentence revise to read:)

"Subject to the foregoing, all appointive ..." add: "No members shall be eligible for election to Supreme Lodge Office or to continue to hold such office who is or becomes an officer, employee, or field worker of or for the Supreme or other superior lodge of any other fraternal benefit society. Persons holding the title of Grand or Supreme Past Master Workman may retain that honor and otherwise fully participate but shall be disqualified from voting in sessions of the Supreme Lodge."

and also recommended amendment of Article I, Section 13 to add at the beginning:

"Subject to the qualification of Section 3 of this Article I, each member ..."

#### DOCUMENT NO. 5

Resolution No. 5 Standing Resolution 2.01 Per Capita Tax

The State of the Order and Law Committees recommended (a) through (e) be amended to read as follows:

#### 2.01 Per Capita Tax

- (a.) Per capita tax shall be \$1.00 per month for each adult member.
- (b.) The Supreme Lodge shall retain the first \$.50 of the per capita tax for the promotion of general fraternal work.
- (c.) Each subordinate lodge shall retain or be paid the portion of the remainder of the per capita tax for each member in good standing as follows (payment of per capita tax shall be at the formula applicable to the month payment received):

- (1.-4.) remains the same '
- (d.) remains the same as (c)
- (e.) remains the same as (d)
- (f.) remains the same as (e)

# DOCUMENT NO. 6

Resolution No. 6 Standing Resolution 6.03 Per Diem

The State of the Order and Law Committees recommended amendment to read as follows:

"Officers, committee members and representatives to the Supreme Lodge shall receive Twenty-five Dollars (\$25.00) per day for each day's actual attendance upon the meetings of the Supreme Lodge, and mileage at the rate of eight cents (8¢) per mile; provided that no mileage or per diem shall be paid to members retiring before adjournment of the session except where leave of absence for a justified reason is granted by a two-thirds vote. Be it resolved that officers and delegates representing the A.O.U.W. at session (Annual Convention) of the Washington State Fraternal Congress, in the performance of their duties and attendance at its various functions, shall be paid by the Supreme Lodge on the same per diem and mileage basis as delegates to the A.O.U.W. Supreme Lodge."

"The per diem herein providid for delegates shall be paid by the lodge from which they are members; all mileage and all other per diem shall be paid by the Supreme Lodge."

#### DOCUMENT NO. 7

Resolution No. 7 Article III, Section 4

The State of the Order and Law Committees recommended the following:
"It shall be the duty of each subordinate lodge to hold at least
one regular or stated meeting in each calendar month, provided that
at least one stated meeting shall be convened in each calendar
quarter of a year. For the purposes of this section a regular
meeting shall be any meeting or activity open to the general
membership for social or fraternal purposes. A stated meeting
shall be one held primarily for the transaction of business. The
lodge is encourage to have social or fraternal activities in
connection with every meeting."

The remainder of the paragraph to remain the same.

The Supreme Recorder cast a unanimous ballot for Helen
Spitler as Supreme Outside Watch and she was declared elected.

SUPREME TRUSTEE, 1978 ~ Frank Ryan was nominated by Isabel Stoffer. The Supreme Recorder cast a unanimous ballot for Frank Ryan as Supreme Trustee and he was declared elected for the term ending in 1978.

SUPREME TRUSTEE, 1979 - Jim Elder was nominated by Robert Doty.

The Supreme Recorder cast a unanimous ballot for Jim Elder as Supreme Trustee and he was declared elected for the term ending in 1979.

SUPREME GUIDE - Eleanor Reeves was numinated by Ralph West.

The Supreme Recorder cast a unanimous ballot for Eleanor Reeves as Supreme Guide and she was declared elected.

SUPREME ASSISTANT GUIDE - Ruby Cusato was nominated by Marie Baker.

The Supreme Recorder cast a unanimous ballot for Ruby Cusato
as Supreme Assistant Guide and she was declared elected.

SUPREME INSIDE WATCH - John Yingst was nominated by Lee Porter.

The Supreme Recorder cast a unanimous ballot for John Yingst as Supreme Inside Watch and he was declared elected.

SUPREME DUTSIDE WATCH - Lu Berg was nominated by Ralph West.
SUPREME DUTSIDE WATCH - Cliff McCammon was nominated by Helen Spitler.
SUPREME DUTSIDE WATCH - Charlett McCaleb was nominated by Robert Doty.

Resolution No. 9 Section 2.03 Standing Resolution

"2.03 Special Interest Clubs:

Lodges may authorize the formation of special interest clubs such as lodge drill teams, athletic teams, dramatic clubs, retired clubs, coin clubs, bowling clubs and others.

No member of any subordinate lodge shall be allowed to participate in any such club unless his or her membership be in good standing."

#### DOCUMENT NO. 10

Resolution No. 10 Article I, Section 9

The State of the Order and Law Committees recommended amendment as follows:

"Representatives and an equal number of alternates shall be elected by the subordinate lodges at the first regular meeting of the second month preceding that in which a regular session of the Supreme Lodge is held, or, if such election be not held, at any subsequent regular meeting of the lodge held prior to the said session of the Supreme Lodge, such representatives and alternates to serve until the next regular election; provided that a lodge instituted after the regular time for holding the election of representatives shall be represented by its Past Master and Master Workman if the lodge be entitled to more than one delegate."

## DOCUMENT NO. 11

Resolution No. 11 New Standing Resolution

The State of the Order and Law Committees recommended adoption as follows:

"When a lodge member moves from one lodge jurisdiction to another his or her lodge membersip will be automatically transferred to the area where he or she then resides; subject, however, to the right of the member making an election to remain a member of the original lodge. While a member resides in a state or area where the Order has no lodge assigned, then membership in the original lodge will be retained."

Supreme Foreman Ray Switzer then gave a speech all to work together to do more in the next two years.

The business of the Supreme Lodge having been completed, delegates and officers formed a circle of friendship around the altar and sang "God Be With You".

Supreme Foreman Ray Switzer declared the Supreme Lodge adjourned sine die.
