ARTICLES OF INCORPORATION

OF

SAWTOOTH FORD SALES, INC.

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, H. JACK BASOLO, JOHN S. SZAFRYK and RICHARD B. HILL, each being residents of the State of Idaho and residing in the County of Blaine, Idaho, each and all citizens of the United States of America, of the age of majority, do hereby adopt and execute the following Articles of Incorporation, and do hereby certify and declare:

I.

That the name of said corporation is and shall be "SAWTOOTH FORD SALES, INC."

II.

That said corporation is formed for the following purposes:

- (a) To engage in the business of buying, selling and/or leasing motor vehicles of all kinds and descriptions and all equipment, supplies and parts of all kinds and descriptions incidental thereto; and to deal in all kinds of merchandise generally used in connection with such business and to engage in any other activity incidental thereto.
- (b) To receive, acquire, hold, purchase, dispose of convey, mortgage and/or lease, real and personal property, to dispose of, sell, lease, assign, transfer, mortgage and/or

convey any rights, privileges, franchises, real or personal property of the corporation, other than its franchise of being a corporation, and to acquire, purchase, guaranty, hold, mortgage, own, vote, sell, pledge and/or otherwise dispose of and deal in shares, bonds, securities and debentures and other evidences of indebtedness of its own and of other corporations, domestic or foreign.

- (c) To conduct business in this state, other states,

 District of Columbia, territories and colonies of the United

 States and in foreign countries, and to have one or more offices

 and places of business out of this state, and to acquire, receive,

 hold, purchase, lease, mortgage, dispose of and/or convey real

 and personal property situate out of this state.
- (d) To enter into, make, perform and carry out contracts of every kind and for any lawful purpose, without limit as to amount, with any person, firm, association, corporation, municipality state or government, or any subdivision, district or department thereof.
- (e) To do any and all such other acts, things, business or businesses in any manner connected with or necessary, incidental, convenient or auxilliary to any of the objects hereinbefore enumerated or calculated, directly or indirectly, to promote the interest of the corporation; and in carrying on its purpose, or for the purpose of attaining or furthering any of its business.

(f) The several clauses contained in this statement of purposes shall be construed as both purposes and powers, and the statements contained in each clause shall be in nowise limited or restricted, by reference to, or inference from the terms of any other clause, but shall be regarded as independent purposes and powers; and no recitation, expression or declaration of specific or special powers or purposes herein enumerated shall be deemed to be exclusive; but it is hereby expressly declared that all other lawful powers not inconsistent herewith are hereby included.

III.

That the location and post office address of the corporation shall be P. O. Box 40, Hailey, Idaho.

IV.

That, subject to dissolution in the manner provided by law, the duration of this corporation shall be perpetual.

V.

That the amount of authorized stock of said corporation shall be 100 shares of common stock of no par value.
