DECREE OF DISSOLUTION

14 The voluntary application, duly verified, filed in the above  
15 entitled Court on March 1, 1976 by Salmon River Enterprises,  
16 Inc., a corporation, and its directors and officers, praying, among  
17 other things, that said Salmon River Enterprises, Inc. be dissolved,  
18 came on regularly for hearing before the Court setting without a  
19 jury on this 15th day of April, 1976, on the said application and  
20 the records and files in said matter, and the Affidavit of Blaine  
21 Cock, one of the directors of said corporation, having been filed.  
22

23 It appeared to the Court from said application and the  
24 records and files in said matter, and the Court so finds, that said  
25 application was filed in this Court on the 1st day of March, 1976,  
26 that an order was duly given, made and entered on the 11th day of  
27 March, 1976, directing that said application be filed with the  
28 Clerk of this Court and that said Clerk give not less than thirty  
29 (30) days notice of such application by publication in the Recorder  
30 Herald, a newspaper of general circulation, published in Salmon,  
31 Lemhi County, Idaho, and that notice has been given and published  
32 as required by said order, and the statutes of the State of Idaho,

1 in such cases made and provided, and that the time for such publi-  
2 cation has expired and that no objections have been made or filed  
3 to said application, and the time allowed by law and by said order  
4 and notice for filing of such objections has expired and that the  
5 default of all persons for failure to appear, plead or file their  
6 objections to said application has been duly entered according to  
7 law.

8 Documentary evidence having been thoreupon introduced in  
9 support of the allegations contained in said application, and the  
10 evidence having been closed, the cause was submitted to the Court  
11 for consideration and decision, and the Court having considered  
12 the evidence and proofs, and examined all matters and proceedings  
13 herein mentioned, duly considered the case and being fully advised  
14 in the premises, further finds:

15 1. That Salmon River Enterprises, Inc. is now and at all  
16 times herein mentioned has been a corporation duly organized and  
17 existing under and by virtue of the laws of the State of Idaho, and  
18 that its principal place of business and its registered office is  
19 now and at all times herein mentioned has been in Salmon, Lomhi  
20 County, Idaho.

21 2. That the authorized capital stock of said corporation  
22 is now and at all times mentioned in the application for dissolu-  
23 tion has been \$100,000.00 divided into 100 shares of common stock  
24 of the par value of \$1,000.00 per share; that the corporation has  
25 issued and there is outstanding 570 shares of said stock.

26 3. That the number of directors constituting the Board of  
27 Directors of Salmon River Enterprises, Inc., as specified in its  
28 Articles of Incorporation and By-Laws is now, and at all times men-  
29 tioned has been four persons; the names of the directors and  
30 officers now in office and the post office address of each are as  
31 follows:

9 and the said named persons are, respectively, the directors and  
10 officers who for more than one year last preceding the filing of  
11 the petition in this matter have had and now have the management  
12 of the affairs of said Salmon River Enterprises, Inc. and all of  
13 them have signed the application for its dissolution.

14 4. That at a special meeting of the stockholders of Salmon  
15 River Enterprises, Inc. duly called and held on the 1st day of  
16 March, 1976, the stockholders of said corporation upon a vote of  
17 the stockholders present, duly resolved the dissolution and liquidation  
18 of said corporation, that 570 shares of the stock of said  
19 corporation were duly represented at said special stockholders  
20 meeting, and at said special meeting a vote of 570 shares of the  
21 common stock was cast in favor of said liquidation and dissolution,  
22 as therein resolved, and no shares were cast against the liquidation  
23 and dissolution, as therein resolved; that 570 shares constituted  
24 more than two-thirds of the capital stock of said corporation  
25 subscribed, issued and outstanding.

26 5. That all claims and demands against Salmon River  
27 Enterprises, Inc. have been satisfied and discharged.

28 6. That all the statements made in said application of  
29 Salmon River Enterprises, Inc. are true and correct and such are  
30 found to be the fact.

31 7. That Salmon River Enterprises Inc. should be dissolved  
32 as an Idaho corporation.

33 NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED:

34 1. That Salmon River Enterprises, Inc., an Idaho corporation,

1 heretofore organized and existing under and by virtue of the laws  
2 of the State of Idaho, shall be, and the same is hereby dissolved.

3        2. That Emerson Moodie, Blaine Cook, James C. Herndon, and  
4        Betty Cook, above mentioned, are the directors of the affairs of  
5        said Salmon River Enterprises, Inc., in office at this time, and  
6        as such and by operation of law, the statutory trustees of the  
7        creditors and stockholders of said Salmon River Enterprises, Inc.,  
8        with full power to settle the affairs of said corporation and to  
9        distribute and convey all of the property of said corporation to  
10      its stockholders in the settlement of its affairs and in complete  
11      liquidation of the corporation.
