That the undersigned, both of whom are citizens of the United States of America and over the age of 21 years, do hereby associate ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we do hereby certify:

I.

The name of the corporation shall be "MULLINS & ASSOCIATES, INC."

II.

Said corporation shall have a perpetual existence unless dissolved pursuant to the statutes of the State of Idaho.

TII.

Said corporation is organized to transact any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

IV.

The total number of authorized shares of the capital stock of this corporation is 1,000 shares of common stock, all of which shall be without nominal or par value, nonassessable, and of the same class.
