

ARTICLES OF INCORPORATION

I, THE UNDERSIGNED SUBSCRIBER OF THESE ARTICLES OF INCORPORATION, A NATURAL PERSON COMPETENT TO HEAL, DO HEREBY MAKE, SUBSCRIBE AND FILE THESE ARTICLES OF INCORPORATION FOR THE PURPOSES OF ORGANIZING A CORPORATION UNDER THE LAWS OF THE STATE OF IDAHO.

ARTICLE 1 NAME OF CORPORATION

THE NAME OF THIS CORPORATION SHALL BE:

ARTICLE 11 NATURE OF BUSINESS

THE GENERAL NATURE OF THE BUSINESS TO BE TRANSACTED BY THIS CORPORATION SHALL BE: HEALING, DEVELOPMENT AND RESEARCH THE HEALING POWER OF LIGHT, FOR ITSELF AND OTHERS, AND TO DO AND PERFORM ANY ACT OR THING NOT INCONSISTENT WITH THE LAW, BUT GIVING ALL POWERS RELATED TO THE CONDUCT OF SUCH A BUSINESS THAT MAY BE NEEDFUL AND NECESSARY IN ITS OPERATION. TO HAVE ALL THE RIGHTS, POWERS AND PRIVILEGES INCIDENTAL TO CORPORATION, TOGETHER WITH THE TRANSACTING OF ANY LAWFUL BUSINESS IN COMPLIANCE WITH THE LAWS OF THE STATE OF IDAHO.

ARTICLE 111 CAPITAL STOCK

THIS CORPORATION IS AUTHORIZED TO ISSUE TWENTY THOUSAND (20,000) SHARES OF ONE DOLLAR (\$1.00) PAR VALUE STOCK.

ARTICLE IV INITIAL CAPITAL

THE AMOUNT OF CAPITAL WITH WHICH THE CORPORATION WILL BEGIN BUSINESS SHALL BE ( FIVE HUNDRED DOLLARS)

ARTICLE VIII GUIDES

THE WORD GUIDE SHALL BE USED IN PLACE OF THE WORD DIRECTOR WHEREVER IT ACCURES IN THE ARTICLES OF INCORPORATION, AN SHALL HAVE THE SAME DUTIES AN RESPONSIBILTIES. THE CORPORATION SHALL HAVE NOT LESS THAN ONE GUIDE NOR MORE THAN SEVEN GUIDES. THE NUMBER OF GUIDES MAY BE ALTERTED FROM TIME TO TIME BY THE BYLAWS ADOPTED BY THE STOCK HOLDERS.
