# ARTICLES OF INCORPORATION?

OF

KOOTENAI COUNTY DEPUTY SHERIFF'S ASSOCIATION, INC.

We, the undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such Corporation.

#### ARTICLE I

The name of the Corporation (hereinafter called the "Association") is KOOTENAI COUNTY DEPUTY SHERIFF'S ASSOCATION, INC.

#### ARTICLE II

This "Association" shall exist perpetually.

#### ARTICLE III

This "Association" is organized pursuant to the Idaho Non-Profit Corporation Act, and is a non-profit corporation.

#### ARTICLE IV

The KOOTENAI COUNTY DEPUTY SHERIFF'S ASSOCIATION, INC., is established to transact any and all lawful business for which corporations may be incorporated under the Idaho Non-Profit Corporation Act.

#### ARTICLE V

The KOOTENAI COUNTY DEPUTY SHERIFF'S ASSOCIATION, INC. shall have the number and qualifications of members as set forth in the By-laws. There shall be one class of members with voting rights on a basis of one (1) vote per member.

#### ARTICLE VI

The initial registered agent of the "Association" shall be Michael J. Vrable, 307 Elder Building, Coeur d'Alene, Idaho 83814.

### ARTICLE VII

The affairs of this "Association" shall initially be managed by a Board of Three (3) Directors. Commencing with the first meeting of the Association, the number of Directors shall be determined as provided in the By-laws of the "Association".
