## ARTICLES OF TROOFFORATION 8 32

OF SECRETARY OF PATTY - ST. JUDE TRANSPORTATION APPORATION

KNOW ALL MEN BY THESE PRESENTS: That the undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

Ι

The name of the corporation shall be Patty - St. Jude Transportation Corporation.

II

The term for which said corporation shall exist shall be in perpetuity.

III

The address of the initial registered office of this corporation in the state of Idaho, shall be 300 First Security Building, Boise, Idaho 83701, and the name of the initial registered agent at that address shall be MTB&B Service Company.

The purposes for which this corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
