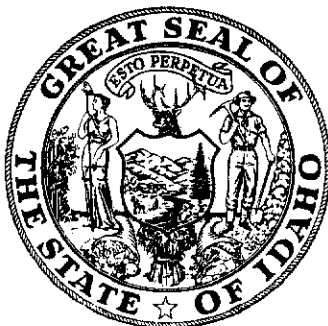

Pursuant to Idaho Code § 30-1-61, and the authority of joint resolution of sole shareholder and director of the corporation dated October 20, 1995, the undersigned officers of the corporation render these Articles of Amendment and represent as follows:

- (a) Name of the Corporation: A-1 Cleaning & Restoration, Inc.
- (b) Amendment adopted: That Article I of the Articles of Incorporation of A-1 Cleaning & Restoration, Inc. be amended to read:

"That the name of said corporation shall be A-1 Restoration & Cleaning, Inc."
- (c) Date of adoption of amendment by shareholders:

October 20, 1995.
- (d) Shares outstanding: 100 shares are outstanding and entitled to vote on the amendment, individually and not as a class.
- (e) Share Voting: 100 shares voted for the amendment; none against.
- (f) Exchange of Shares: Such appropriate exchange of certificates evidencing ownership in the corporation shall be made so as to preserve the existing shareholder interests in the corporation and so as to provide shareholders with certificates properly designated in the new name of the corporation.

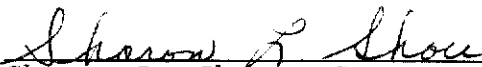
